**TMD Made Easy**

What causes people to grind their teeth? Stress, correct? Recent studies have suggested that the airway may be the cause of bruxism in some. TMD conditions can be induced by bruxism. As more studies continue to be undertaken, we are starting to see that these issues may all be connected. Dr. Kuehne will cover the basics of the anatomy associated with the TM joint, the most commonly seen TMJ issues and how to properly diagnose/treat those issues, and how obstructive sleep apnea is related to TMD.

**Sleep Medicine for the General Dentist**

General dentists are in the unique position of seeing their patients every six months on average. It should be every dentist’s responsibility to screen and, when appropriate, treat their patient base for the serious medical condition known as obstructive sleep apnea. Dr. Kuehne will lead a discussion to include the basics of upper airway anatomy, an overview of the importance of treating obstructive sleep apnea, screening and diagnosing, examination, appliance selection, side effects of oral appliances, and practical pearls of treating obstructive sleep apnea.
